



Pursuant to Article 32. and Article 60. paragraph 1. item 1) of the Law on Public Procurement ("The Official Gazette of the Republic of Serbia", No.124/2012) and pursuant to the Decision No. IN 848/17 from 25th October 2017, on carrying out a public procurement procedure VJN 08/17, the Building Directorate of Serbia Llc, 110 Bulevar Arsenija Carnojevica Street, Belgrade,

Hereby publishes the following:

INVITATION FOR SUBMISSION OF OFFERS IN A PUBLIC PROCUREMENT PROCEDURE VJN 08/17

- 1. Name, address and website of the Purchaser:** Building Directorate of Serbia Llc, 110 Bulevar Arsenija Carnojevica Street, Belgrade. **The website of the Purchaser:** www.gds.rs
- 2. Type of purchaser:** Business company
- 3. Type of public procurement procedure:** Open procedure
- 4. Description of the subject of the procurement:** Execution of all preparatory works (preparation of required layout drawings), Preparation of Technical documentation for building - F, Construction works on building- F and Works authorized by the Purchaser, on a "Design and build" basis in the "Zemunske kapije" settlement in Zemun, all in accordance with the list and description of services and works on construction of buildings, Vendor lists of materials and equipment, which are given in Part 3 of the Tender documentation;
Designation in the General Vocabulary of public procurements:
Code: 71220000 Design services in architecture
Code: 45000000 Construction works
- 5. The criterion for contract award:** the economically best suited offer, with the following basic elements, all in accordance with the Tender documentation for this public procurement:
 - 1. Price offered** **ponders = 55**
 - 2. Deadline and schedule for completion of works** **ponders = 35**
 - 3. Quality for execution of activities** **ponders = 10,**

where the above mentioned elements of the Criterion for contract award are broken down in detail and given in the Tender documentation.



- 6. - 7. A way of submitting the offer:** The offer has to be prepared on the whole in compliance with this Invitation and Tender documentation for public procurement. Offers are submitted on the forms of Tender documentation in a sealed envelope with a note: "An offer for a public procurement in an open procedure for VJN 08/17 - DO NOT OPEN". It is necessary to indicate on the back of the envelope the business name and address of the tenderer.
- 8. The deadline for submission of offers** is 18th December 2017, until 08:30 a.m.
- 9. Place, time and way of opening of offers:** The opening of offers is on 18th December 2017 at 09:00 a.m. in the premises of the Purchaser in Belgrade, 110 Bulevar Arsenija Carnojevica Street , Belgrade-New Belgrade. The opening procedure shall be public and shall be done according to the time of the receipt of offers from the earliest to the latest offer received.
The Purchaser will organize a site visit of the future construction site on 27th November 2017, starting at 12:00 a.m.
- 10. Conditions under which the tenderers may participate in the offers opening procedure:** The offers opening procedure will be open for attendance of authorized tenderers' representatives who are required to prove their status of the tenderers' representatives by submitting the authorization which is signed and certified by the authorized person of the tenderer to the Committee for public procurement or the Procurement Officer, immediately before the opening of offers.
- 11. The deadline for making a decision on awarding the contract:** The deadline for making a decision on awarding the contract is up to fifteen days from the day of opening of offers.
