4. **Description of the subject of the procurement:** preparation of technical documentation (preliminary design with feasibility study, project for acquisition of a building permit, project for execution, as-built design), (hereinafter referred to as design) and construction works for the purpose of expanding the capacity for the conduct of international road transport at the border crossing Batrovci on the highway E-70

Street 110, Belgrade-New Belgrade: It is necessary to indicate on the back of the envelope the business name and address of the tenderer.

The opening procedure shall be public and shall be done according to the time of the receipt of offers from the earliest to the latest offer received.

Conditions under which the tenderers may participate in the offers opening procedure:** The offers opening procedure will be open for attendance of authorized tenderers' representatives who are required to prove their status of the tenderers' representatives by submitting the authorization which is signed and certified by the authorized person of the tenderer to the Committee for public procurement or the Procurement Officer, immediately before the opening of the offers.
